	For Need Based Aid, complete the 2024-2025 Free Application for Federal Student Aid (FAFSA) online at <a href="www.studentaid.gov">www.studentaid.gov</a> . It is highly recommended that the student start the process and invite contributors to add their information. This year you will see SAI and not EFC due to changes made by the Department of Education.
	*Please note that your file may be selected for further verification to complete the review of your aid. If additional documentation is requested, it is <b>required</b> that you to submit requested forms immediately to ensure timely processing of your financial aid.

## NOTES AND UPDATES: IMPORTANT THINGS TO KNOW

- Satisfactory Academic Progress (SAP) will be evaluated once Spring 2024 grades are posted. The SAP policy can be found at: <a href="https://www.ursinus.edu/financialaid/sappolicy">www.ursinus.edu/financialaid/sappolicy</a>. Students who do not meet SAP requirements will be notified by the end of May by both an email and a letter to the home address on file.
- Financial aid will be renewed to returning students who have met SAP requirements and turned in all required documents starting the end of May.
- Your award letter will be available on the self-service portal; you will receive an email when it is ready to view. Please review the terms and conditions of your award under the Policies and Procedures section online at <a href="https://www.ursinus.edu/financialaid/policiesandprocedures">www.ursinus.edu/financialaid/policiesandprocedures</a>.
- If you were awarded the UC Fund in previous years, you must file a FAFSA to be considered for renewal of this award. If your financial need has changed, all need-based aid may be subject to

change.

- All accounts must be paid in full by the due date listed on your invoice. You will not be permitted to start classes or move onto campus if you have an outstanding balance due.
- If you would like someone other than yourself to have access to your financial aid award, please add them as a Proxy (if you have not already done so) on the self-service portal.

## FINANCING OPTIONS: A PLAN MUST BE IN PLACE PRIOR TO THE BILLING DUE DATE

_	If you are interested in applying for a Federal Direct PLUS Loan for parents, apply online at <a href="https://studentaid.gov">https://studentaid.gov</a> after June 1, 2024. The Free Application for Federal Student Aid (FAFSA) must be completed to be eligible to apply for a PLUS loan. Remember to apply for the full academic year and keep in mind that the government retains 4.228% in origination fees.  If you are interested in applying for a private Alternative Loan, please go to the website <a href="www.elmselect.com">www.elmselect.com</a> for further consumer information. Apply online after June 1, 2024. Remember to apply for the full academic year.
